About Inclusion North



Inclusion North is a not for profit Community Interest Company.

We exist to make inclusion a reality for all people with a learning disability or autism and their families.

A group of Directors make sure Inclusion North is doing a good job and following the law.



The Directors include people with a learning disability or autism, family carers and professionals.

They are supported by an Advisory Council. There are 18 people on the Advisory Council. Half of these are people with a learning disability or autism, or family members. The rest are people from support services, Partnership Boards or other organisations.

Being an Inclusion North Director



Inclusion North are looking for up to four people to join our Board of Directors.

We are looking for one person with lived experience as a family member of someone with a learning disability or autism.

We are looking for up to three people with other business skills, such as commissioning or managing health or social care services, accountancy, human resources or law, or entrepreneurs with an interest in social enterprise.

This is a voluntary role. This means you don't get paid for doing it.

All Directors can claim expenses for coming to meetings or any costs they have in doing their volunteer role. This means we pay things like train fares or the cost of travelling by car.

What does it mean to be a Director?







The Board of Directors are responsible for:

- 1. Running the Company well making sure Inclusion North follows Company Law and our own internal rules
- 2. **Managing the money** making sure that Inclusion North have enough money and spend it the right way
- 3. Checking the work we do making sure it is good quality and fits with our values
- 4. **Supporting the Chief Executive** helping her to manage the staff team and develop the company
- 5. **Thinking about the future** planning ahead to make sure Inclusion North meets the needs of its members and customers
- 6. **Making sure people know about Inclusion North** sharing information through their own networks

What do Directors do?





The Directors meet 6 times a year, usually in York. The meetings are usually from 1pm to 3.15pm on a Friday.

They also meet twice a year with the Advisory Council and the staff team in a big meeting that brings everyone together. These meeting are usually 10.30am to 3pm.

Directors get reports to read before each meeting. These are all in Easy Read format.

At the meetings, Directors bring ideas, ask questions and make decisions.

Meetings are run by two Co-Chairs. One has a learning disability or autism.
